Terms and Conditions.

1. The subscription license comes complete with manuals, 3 button mouse and unlimited free technical support via phone, fax and email.
2. The software is to be paid for in monthly blocks, and can be cancelled at any time. All payments must be made in advance.
3. Software may be stopped and restarted at any time.
4. All updates are shipped directly to the customer as released with updated manuals.
5. Postage and Handling is only paid for in the original purchase.
6. Cancellation of subscription must be submitted in writing 5 days before the end of the monthly period.
7. Upon receipt of cleared funds each month AppliCad will provide the "unlock key" for that month, via email, fax or phone.

8. Sufficient clear funds must be in the account to be debited on the day before the due payment date and on the due date.
9. If there are insufficient clear funds available in the account to be debited on the due date and no other arrangement exists, Applicant:
 - does not have to provide the software keycode until payment is made.
 - may process the payment on a later date when clear funds become available (but will not be obliged to do so) and may charge a fee.
 - may charge a Payment Not Made fee if there are insufficient clear funds on the credit card on the due date, or the day AppliCad attempts to make the payment.
10. When the due date occurs on a weekend or public holiday, the payment may be made on the next business day.
